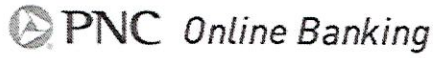
I'm glad to report that all service positions has been filled also that there are addicts willing to come and support All sub-committee I'm pleased with the support that is being shown.
