Discussion of BARCNA, KRSCNA, KBARNA participation together – Shane C. and Caitlin F. are present from the Bluegrass Appalachian Region; they both represent committees directly responsible to Kentuckiana Region – i.e. Shane is facilitator of the Fellowship Development Committee which is part of the Southern Zonal Forum which Kentuckiana is a voting member of, and Caitlin F. is the RD for their region but serving on the joint regions' service body KBARNA as the AD for the next world service conference (she serves with Mike P., our RD) They are present today just to give information, reports, and be of service if the region needs anything.

Treasurer's Report Balance 15, 807.57

One check to LA \$1200.00 NACK \$5.11 extra returned LA donation check \$100 was sent before motion carried to quit sending \$ to region was passed

Across the Rivers Area gave \$540.00 in September – some from previous months' checks

Total of \$675.++ donations to region since last regional mtg.

Treasurer emailed reports to all on region list (attached or follows)

Did anyone not receive? 502 not on list? Kevin D was on the list; all areas received his reports

RD Report – Mike – we attended SZF and we have a FD committee and they have been working on getting groups together and helping with Zoom mtgs, etc. I'll ask Caitlin to discuss collecting ;7th Tradition on Zoom/virtual mtgs; her presentation; Shane and La RD Lee are working together on FD, and there was a workshop that was invite-only and Jackie will give more about that (See NACK area report) Conference Participants WEBINAR on Oct 17 – GWSNA on conference review, NAWS NEWS will be shorter, Instagram account, you can email social media at www.na.org.

Asking for members' input, local service toolbox information needed, IDT 2 left over – DRT and MAT, and also VIRTUAL mtgs, which will be the first focus; Virtual workgroups, SPAD, and FIPT project working; 6 month review period for any FIPT changes; zonal delegates to be full conference participants- this will be in CAR 2022, Loner IP revisions and new Women in Recovery IP in progress; NAWS won't know financials soon; must consider inhouse productions, legal expenses, the Legal Case.

NAWS position was upheld by the judge; it cost the fellowship \$218,000 to deal with the legal petition; trying to reschedule WCNA 2021 into 2022; a one-cycle thing; one year they happen to be together; turned down grant IDEL, asking if we want to accept loan forgiveness, donate now at www.na.org, operating expenses/working days for NAWS are very limited...

Discussion of legal petition and possible future actions by the fellowship in response. RD Team will ask NAWS for more information i.e. possibility of filing against those who petitioned and caused us the \$218,000 loss of fellowship funds.

SPAD – 4 spiritual principles still asking for input til Dec 31; afterward there will be 4 more principles for input; at next Zonal Forum, we will have a workshop on SPAD, and those new 4 principles; our chair at Zone is very involved and will be helping out; when pandemic first started; we had lots of input, but as it's wained on, we've gotten less and less input; please go to NAWS website and give input so we can get book together and be a part of writing our literature Jackie read from the NACK area report and described. There's a new IP Women in Recovery and this may be content for that. If you need information on collecting 7th tradition on Zoom, Caitlin has more information on that.

Discussed what was approved at WSC2020 – (Jackie will re-send RD report from last region)

AD REPORT – Jackie G– Discussed 2 KBARNA policy change needs; can be dealt with as our region/areas/groups want us to handle it

LARRY – KRCNA 34 - We meet today – no report – we are working diligently – we're making good decisions on how 34 will go; we will keep you posted; questions?

MIKE – KRCNA 35 – we meet every 2 months – not doing a whole bunch, pre-convention t-shirts available, working on a flyer, 2 colors on shirts, still asking for artwork for convention; Frank took some t-shirts to Evansville on Halloween, sold \$190 of shirts there; making a little \$ here and there at functions. Still need a secretary, a hotel & hospitalities chair, and an entertainment chair; asking for people's input from all over the region; meeting on ZOOM, wherever you are, you can attend and participate

Rodney mentioned LONE STAR regional convention is meeting same weekend as proposed dates for KRCNA 34; can get contacts for more information

Across the Rivers Glad to be back at regional service; not much to report TJ

Turkey Day in November – flyer is out, includes ticket auctions for places in line

(Note from Jackie G – I had trouble hearing TJ on the Zoom connection; please add pertinent information I may have left out)

LOUISVILLE AREA – first weekend January – convention still scheduled, but pandemic is still spiking, so not certain if that will change; financial situation in Louisville area – money is not running out, but we have more outgoing than incoming...we will revisit fund flow at first of year when we have budgets for 2021.

OVANA – TODD – not much to report, waiting for nominations, I will be RCM for next year, RCMA waiting, some discussion of our area meeting Nov 29 or we may do Zoom on holiday weekend;

OWENSBORO – TONY – mtgs going on , not at regular place; we meet at shelter at English Park, oncoming winter weather – we are looking at moving mtgs a few blocks away, mtgs are meeting confirm whether to move or not, rent is steeper, but they are allowing gatherings at that church – as soon as we know, probably Dec.

We can put out info on where we will be meeting; mtgs are being attended, a couple of Zoom mtgs , lot of home groups starting to meet in person again, we are using CDC guidelines and keeping it all safe as possible.

502 Area – Karen – we have online meeting lists, if anyone wants to be added, just let them know, all home groups currently meeting online exception is 1 group meeting in person, COVID cases spiking locally, no PR projects, our treasurer is sick with cancer, any support appreciated.

New Business:

Nomination for Karen D to be vice-chair

NACK motion made to accept nomination - first, Owensboro 2nds, nomination for Karen D. as vice-chair ,nomination accepted; Jackie will add her resume to minutes,

TJ Just for Today home group wd like to nominate Kevin G. as secretary....2nd Owensboro – Kevin discussed his qualifications, August 10, 2004, various positions, sponsoring, listed positions, some resources = detail-oriented, punctual, able to meet deadlines, served on multiple committees, also in his employment, currently treasurer for home group, see attached

Kevin – unanimous support – elected today Secretary position has been open for a long time

Discussion of Karen’s nomination and when it can be confirmed; policy is set to be sensitive to area meetings getting information voting and getting back to region; PANA and Owensboro may need more time than just the Jan meeting; discussion of time-consuming constraints with other areas; when we changed region to every other month, this changed and caused the issue; region should accommodate the areas, not vice versa. Tony – we will bring it up at the next region; areas that are able and want to bring their conscience in Jan. may do so; Mike – areas who meet every other month – we sometimes have to meet 3 regional mtgs in order to get business back to region; Tony – this is a policy change; we would need a motion, take it to groups, then a 2/3 approval to change. TJ – I agree with Rodney the problem with taking it a half year to get anything done comes from region meeting every other month; when region met monthly it was not such a problem. If region were meeting every month, we wouldn’t have this big of a problem; regional members should not go back to tell areas what to change in order to help region. Rodney-the discussion is ours, not our groups; something with this critical this degree of change should come from the groups, like even the nomination came from an area, not a home group.

KBARNA policy change requests - Jackie G. will send the proposed policy changes for KBARNA will be sent out in minutes. Areas will consider to accept as written, decline as written, and/or offers of revised wordings. Chair – then Region will take action on this at next region.

MARK S – his term is coming up, Owensboro made motion for MARK S to continue as treasurer, 2nd by NACK, take it back to the areas for any additional nominations, nominations still open...

TONY – one home group in Owensboro had been in one place for over 25 years, other groups came to 5th and St. Anne. It came up to how do we get the word out that the meetings are changing locations.

Shane said there is a PR discussion going on at zone and world about this discussion.

SHANE – Survivors Area and Bluegrass Appalachian trusted servant; also Zonal trusted servant. This past Thursday we did MAT PR event with Voices of Hope; Survivors Area presented, and Voices of Hope invited others; then their contact from Louisville asked if we could do an event in January for them; screenshared Voices of Hope information; they are part of Association of Recovery Community Organizations =several locations in KY and IN, IL, because the event went so well, they asked if we can host an event in Jan. They asked questions about MAT-friendly meetings, who will sponsor patients on MAT, what's the difference in caffeine, nicotine, etc. just to clear up confusion. Great conversation. We want to make sure Kentuckiana is invited to this event and we can plan other events. Voices of Hope just puts together information and shares; Voices of Hope is a freestanding organizations, PAR freestanding/advocacy group, DISCUSSION: Rodney familiar with PAR and says they are primarily promoters of AA....Shane-we would co-host an event to educate NA information how we function, help addicts, find meetings, sponsorship, etc. We don't know if any one particular group would attend. There is confusion and concerns in the outside communities about NA.

Discussion – Owensboro Area does PR events with local organizations also

Shane – we know the event will happen; Survivors Area will host it; probably be first 2 weeks in Jan in late afternoon during a workday; probably 90 minutes; set up in presentation from NA members, Power Point, basic information, facilitators would be in breakout rooms for small group discussions, what would be useful information, and a main mtg closing with reports. Main things – they would know basics about NA, how to find NA all over KY, how to connect persons with NA as aftercare, give them website info, etc. ZOOM virtual – not in person -

We can do postings for Kentuckiana Region so anyone searching can find either region in searching. We have Indianapolis and Atlanta trusted servants helping; we boost posts -we have several instructional videos; Shane can add the area links if our areas wanted it; the Northstar Home Group has been online since May 2018. We've can post it how you all choose. We can make a post example \$15 to reach 1500 possible, we can do that. When we did KY as a whole, we did a Kentucky Survivors Area boost – 773 people reached, 42.6 women, 57.4% men – shows us county by county, other audience details..... are AREA LINKS there? Shane can add area info, and if area wants to boost a post and pay , we can do that, we can do one for region, if your area is interested, our home group Northstar could probably fund it. Shane showed how to boost a post. Shane says VRC Convention will be totally virtual this year....We can help conventions that go virtual...VRC can donate for a joint PR effort in KY – PSAs can be paid for by the Volunteer Region. We want to share the Kentuckiana Region information if everyone is ok with that. Tony will let Chris know....If convention 34 must go virtual, we can help....were happy to help. Shane is the FD Chair for the Southern Zonal Forum. Muliple Zones are helping with a multiple speaker/ jam in late December. Is this region interested in helping, we can include the region.

Lee RD from La is FD trusted servant also. Zonal meets next in January...but this speaker jam is going on in December. If you all have suggestions on content, etc. of our zonal portion of the multi-zonal event, let us know. It's up to you all.
