This is the LASCNA treasurer report for the period ending May 31, 2022. The beginning balance on May 1, was \$21,302.40. We had a total deposit in the amount of \$1,676.16. Of that, \$738.77 is from homegroups 7th traditions and donations, and \$937.39 from literature sales. We had withdrawals totaling \$6,333.73. This includes \$873.73, our literature order to Lone Star Region and \$5,460 to LACNA Convention 32 (which includes seed money as well as early registration).





**** There is little to no added cost to all of these proposed motions. They simply allow us an opportunity to take greater advantage of technology to help grow the NA Fellowship through discussion and mentorship.

Conference Participants Webinars

<u>Motion 1:</u> Stream all Conference Participants Webinars to a media platform accessible to all NA members (currently YouTube), in a manner similar to the current WSC, with a bare minimum of audio and video content.

- The bare minimum of content being an audio stream of the discussion and at least a screen share of the Presentation slides / Co-Facilitator's Screen / or some other fixed image. This manner would at minimum allow members to avoid being recorded with their faces on video from the media platform stream.
- Should the Conference Participants vote to allow a greater level of content to be streamed, such as faces, they would be within their rights to approve a greater level through the normal process of decision making. This motion is only concerning the minimum level, not the maximum level. We believe that there is a minimum level of content necessary for an enjoyable experience for those watching the stream from the currently used media platform.

Intent: To allow the entire NA membership a better understanding of what takes place during CP Webinars.

- This would also allow potential CP trusted servants a better understanding of what their role may be if elected to a CP position.

SCKANA continues to thrive, and April, May, and June are chock FULL of celebrations, with many celebrations being held at various meeting s throughout the week.


