

The H&I Subcommittee exist to carry the Narcotics Anonymous message of recovery from addiction to residents of facilities who do not have full access to regular NA meetings.

Old Business: Our new budget is \$2,500.00 annually. To date \$30.00 have been spent on rent leaving \$2,470.00 in our budget for the year.

Literature: We spent **\$ 0** on literature for the year.

Panel Coordinator's Report: We are not doing any H and I meetings. When a facility POC contacts us for a virtual H and I meeting we refer them to our website for a regular virtual meeting.

New Business: We have created a H and I Ad-hoc committee to explore our options with virtual H and I meetings and we are submitting a motion to area to send to the home groups to vote on area forming an Ad-hoc committee to evaluate how H and I should proceed during and after these disastrous and trying times. How H and I proceeds is a group conscience decision and we should take great care in this process. The decision to adapt virtual meetings for H and I if approved will change H and I in Louisville forever so a conscience contact is truly needed.

Despite all our losses we are still a vision of hope to the still suffering addicts in facilities throughout our area. Facilities are calling for us to come virtually and share our message of recovery, the NA way.

H and I is requesting that our area create an Ad-hoc committee to evaluate the cost and effectiveness of virtual H and I meetings. The decision on how H and I should proceed during this unprecedented time is not one for the sub-committee, but for our area fellowship (group conscience). This decision should be a permanent change to the H and I policy and after the details are worked out another motion to change the literature will be filled. (To this date only \$30.00 have been spent out of our budget (rent))
Reason for change or intent of motion:
Due to the coronavirus pandemic (March 12, 2020), state and federal guidelines, H and I ceased in-person meetings at all our current facilities and have not resumed (non-essential service volunteers). Virtual meetings are the answer to how we can carry our

message without personal contact throughout the pandemic and into the distant future after the pandemic. I have been contacted by addicts and facility POC's wanting a H and I meeting, and I am referring them to our area website to find a virtual meeting. H and I membership have dropped since the pandemic and the one's who are left have medical/underlying issues which are preventing us from doing as many or any in-person meetings if allowed and no one is signing up. There may be a few still willing to take a meeting in and in that case, we will follow the facility guidelines for protection. We have our own Ad-hoc committee to see what kind of virtual meeting will be best suited for our need and we are willing to sit and share information with the area Ad-hoc if created. My prayers and condolences to all who have lost loved ones during this time. We do recover and when one door closes another one opens.
