This is the LASCNA treasurer report for the month ending October 31, 2020. The beginning balance on October 1st, was \$17,149.92. The ending balance on Oct. 31st, was \$14,312.61. This includes total withdrawals of \$4,193.00. \$43.00 to Life Storage, our Storage unit # 307, (Monthly Rental). \$50.00 to NAWS, Inc. (Monthly donation.) \$4,000.00 to LACNA (Seed money for Convention). \$1,000.00 to KRSCNA, (Monthly Donation). We had total deposits of \$1,355.69. \$155.69, deposits from 7th tradition and donations from Home Groups. We had a \$1,200.00 donation from KRSCNA, which is all of the donations made this year to KRSCNA. One \$1,000.00 and (2) \$100.00 donations coming in.
