Dear Louisville area,

**All GSR's (A) please read aloud at your meetings and home group meetings. H & I needs all of our members continued support.**

**The H&I Subcommittee exist to carry the Narcotics Anonymous message of recovery from addiction to residents of facilities who do not have full access to regular NA meetings.**

**Old Business:** The motion to cut the H & I Budget was submitted last month per suggestion of LASCNA due to a decrease in regular meetings and lack of 7<sup>th</sup> Tradition donations from Home groups within our Area. The motion, if passed will be entered on page 30 of the LASCNA P&P manual cutting our budget from \$4,280.00 to \$2,500.00 annually.

**Literature:** We spent \$ 0 on literature for the month of January and February, 2020 due to no LASCNA Treasurer. Literature is a key component for H & I meetings and in our efforts to further carry the NA message of recovery to the still suffering and potential addicts.

**Panel Coordinator's Report:** We are currently carrying the NA message of recovery into 12 of 15 facilities and are in service to at least 2500 addicts monthly.

**New Business:** There is no new business.

**H & I Budget:** Last year's H & I Budget is complete: Last year we spent \$2,596.86 of \$4,280.00 leaving \$1,683.14. For more detail I have attached a copy of our Budget Report for February 2019 through January 2020. As of this year we have spent \$15.00 for rent for February.

We have many openings available and are always looking for new members. We suggest that any interested member get with their sponsor, sponsees, and/or home groups to evaluate whether **H & I** can be a way for you to commit and get involved in area service.

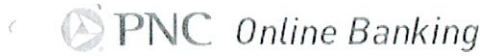
