October 2019 Vice Chair Report

Helio Family,

I would like to announce that I will not be seeking another term on the Executive Committee in any capacity. That means that nominations for Vice Chair and Treasurer need to come forth from home groups. We have been this year without a treasurer and I have been fulfilling the duties, but after January 2020, I will no longer fill this role, regardless if a treasurer has been nominated and voted in or not. I would like to remind homegroups of the importance of this position. Without a treasurer, there will be no one to write checks for our Area bills and other expenses, meaning that no business will be able to move forward and we will lose our storage facility due to non-payment. The best case scenario would be for nominations to be made at the next Area so we can have someone voted in by December and I can train the new treasurer in January. Ideally, the same will occur for the Vice Chair position.

On September 9th, I met with the Chair of the Executive Committee and the PR Chair to write checks that were necessary for the Area's bills to be paid for the month of September, since no Area took place last month. Only 4 checks were written in September and no deposit was made. The checks for September totaled \$426.52.

As of 09/30/19 our bank balance was \$9547.51. In August we took in \$820.99 in 7th Tradition Home group donations and took in \$1071.66 in literature sales. The Secretary also returned funds of \$177.16, from the printing and mailing of the July minutes. We wrote checks totaling \$2,597.37 in August. There is one outstanding check totaling \$50. After deducting the amount of checks written for August and September (2597.37 + 426.52 = 3023.89) and adding the money deposited in August (2069.81) from our previous balance, we have a current balance of \$9,497.51. When we deduct our \$6520.00 prudent reserve we have \$2977.51 to conduct business in October.




