H & I will be conducting a literature drive for facilities that we service who are in need of **Basic Text**. Not all of the facilities that we take meetings into have a budget for literature making it hard for the potential addicts and still suffering addicts to find the identification with NA necessary to make a choice and accept recovery in our fellowship.

My personal experience, many years ago, is that although we did not have H & I meetings at our treatment facility I bought my first **Basic Text** at an NA meeting. The facility taught AA recovery but I read my **Basic Text** daily because I found me, part of my story, and Hope in our literature. I'm hearing the same experiences from addicts in facilities today and they continue to tell me that they don't have **Basic Text** to read so the need is great.

All donations can be made to any member (**Trusted Servant**) of H & I and I will have the ultimate responsibility of totaling donations and disbursing the literature and I will provide, in our area minutes, an ongoing and final total.
