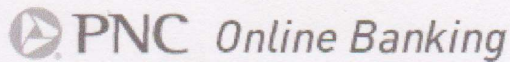

Hello Family,

It's been a busy month for PR. We got lit stands to a few more places: Goodwill Opportunity Center on East Broadway, New Leaf Clinic, the homeless drop-in center operated by VOCAL Kentucky, and Shawnee Christian Healthcare Center.

We did two events this month. Both events were very successful. Several addicts asked about NA and so did several organizations. We handed out meeting schedules and IP's. I purchased a tent, a tote, and a notebook to be used at events. We need the tent for outdoor events because it rains sometimes. We need the tote to carry the literature that we use at events. We need the notebook to write down the contact information of any organization that requests a follow up. People usually want to buy the books that we have on display when we do events, so I am also going to be purchasing some books to sell at future events.

I have asked an addict to change the way that we do the meeting list on our website. We will be using a program called BMLT. It is the same program that we use for the meeting list on our helpline. By using BMLT, it will be easier to or us to keep the meeting list up-to-date. You will also be able to search for meetings. You can search based on the city the meeting is in, the facility the meeting is in, the name of the home group, the format of the meeting, or whether the meeting is virtual or in-person. The addict who I asked to make this change is a member of our fellowship and an IT professional. He will not charge the Area any money.
